Our school population is declining over the years,, as seen throughout California. Our current population is 1480. We have 131 RFEPS (recently Reclassified Fluent English Proficient speakers) Mrs. Storey explained the reclassification criteria (state exams, local measures, teacher recommendation) and explained that we are required to monitor RFEPS for four years after reclassification.

Student Demographic totals were clarified as Mrs. Storey reviewed the data. She also reminded the group that CAASPP data is from 21-22 (during the hybrid year following the pandemic), so the test was shortened. Additionally, iReady was not given at the end of last year, so the data on test scores is not as accurate as it has been for prior SPSAs. This year we will be focusing on "growth scores" instead of just purely grade level achievement.

At 7:20 we broke into jigsaw groups to deep dive into one goal area per group. A question was raised about how to determine who is socioeconomically disadvantaged. It was clarified that Free and Reduced Lunch is the primary measure.
